Action Items – midyear allocations

1. Reallocate IT Mod Local Court Project Funding (Humboldt and Nevada)
2. Confirm IT Mod Branchwide Allocation (Los Angeles)

1. Local Court Project Funding

Background:

- One court returned funds early; there is limited time in which to redistribute to another court
- Two courts –
 - Experienced submission error (attempts verified)
 - Were not included in initial allocations (though funding would have been allocated)

Request: Consider approval of recommended proposals and a reallocation of funds

Processing:

- 4 projects reviewed and 3 recommended (per review by ITAC Workstream Sponsor and staff)
- Confirmed – courts can meet the encumbrance deadline
- Applied FY 25-26 funding methodology to request (courts would have received pro rata portion)

Requested Action

Recommend the following direct allocations:

IT Mod Type	Superior Court	Projects	Allocation
Local Court Project Funding	Humboldt	(1) Digitization project	\$41,273
Local Court Project Funding	Nevada	(1) Data Warehouse project (2) Dashboard project	\$30,471

If approved: Proceeds to Judicial Council Feb. 19-20, 2025

2. Branchwide Funding

Background:

- Sept. 9 – Technology Committee approved IT Mod Branchwide Funding Budget ([Materials](#))
- Automated Messaging & Notification System (AMNS)—budgeted \$125,000
- Service offers automated notifications (e.g., for court hearings) for participating courts
- Service realizes economies of scale; and benefits from common solutions
- In prior years, funding is directly allocated to Los Angeles, which maintains AMNS system

Requested action:

- Since budgeted for previously, confirm direct allocation of \$125,000 to Superior Court of Los Angeles County for AMNS

Note: Allocations to trial courts require Judicial Council approval

Requested Action

Recommend the following direct allocation:

Branchwide Funding	Los Angeles	(1) Automated Messaging & Notification System	\$125,000

 - Public Access Portal
- Legislative mandates
 - Web accessibility (April 24, 2026)
 - Prop 36 – eCitations (funding needed)

Infrastructure	28	26
Courthouse	21	15

Includes all Courts of Appeal and 57 trial courts

Proposed Funding Priorities

Branch Priorities (ranked)

1. Cyber/Information Security
2. Case Management Systems
3. Infrastructure

Increased weighting given to projects that demonstrate:

- High public benefit
- Strong collaboration across courts
- Alignment with baseline cybersecurity priorities (e.g., multi-factor authentication, endpoint protection)

Proposed Expectations

Projects

- All project proposals welcome regardless of branch priority
- Project proposals will be ranked by the workstream

Funding

- May not fully/partially fund all project proposals, including those that qualify as a branch priority
- May not guarantee funding for all courts
- IT Mod budget availability subject to change
- Decisions may be impacted by compliance with reporting and expenditure deadlines

Process: Submitted as one application from **Lead Court**

- Compliance with branchwide policies and standards


2. Modernization (not maintenance)
