1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above ("Agreement"). As set forth in the Agreement, the term "Contractor" refers to **B2B Supplies USA LLC dba Printing Supplies USA LLC** and the term "Judicial Council" or "State" refers to the **Judicial Council of California**.

2. This Amendment becomes effective on: **October 1, 2025**.

3. The parties agree to amend the Master Agreement as follows:
 - A. Pursuant to Appendix C, General Provisions of the Master Agreement Terms and Conditions, Section 5, Option Terms, the Judicial Council hereby exercises its option to extend the Master Agreement for the Third Option Term period beginning October 1, 2025, and ending September 30, 2026. The expiration date of the Master Agreement is hereby changed from September 30, 2025, to September 30, 2026.
 - B. In Attachment 1, Cost Sheet, Revision 2, only the following items have price increases:
 - CF280X- \$93.71
 - CE255A- \$116.79
 - CE390X- \$129.85
 - CF283X- \$39.34
 - CF281X- \$148.12
 - CF226X- \$104.30

4. Except as provided in this Amendment, all terms and conditions of the Agreement, as previously amended, remain in full force and effect.
