Under Government Code 69958, the Judicial Council is submitting the semiannual *Report of Electronic Recording Equipment Purchased or Leased by Superior Courts*, for the reporting period of January 1 through June 30, 2024.

For this reporting period, six superior courts reported a combined total of \$1,184,376 for the purchase of electronic recording equipment or related items (see Attachment A):
