Dear Ms. Jenkins, Ms. Contreras, and Ms. Parker:

Under Government Code section 69958, the Judicial Council is submitting the semiannual *Report of Electronic Recording Equipment Purchased or Leased by Superior Courts* for the reporting period of July 1 through December 31, 2024.

For this reporting period, six superior courts reported a combined total of \$460,024 for the purchase of electronic recording equipment or related items (see Attachment A):

- Napa—\$815 for use in infraction, limited civil, and misdemeanor case types.
- Nevada—\$66,749 for use in infraction, limited civil, and misdemeanor case types.

- San Francisco—\$117,252 for use in misdemeanor and other case types. 1

- Santa Clara—\$134,775 for use in limited civil and misdemeanor case types.
