#### OPEN MEETING

### DISCUSSION AND ACTION ITEM (ITEM 1)

#### Item 1

Recommended Allocations for the Substance Abuse Focus Grant (SAFG) and the Dependency Drug Court (DDC) Augmentation

Carrie presented to the committee members an overview of the Substance Abuse Focus Grant and the Dependency Drug Court augmentation. She also introduced the recommended allocations of fiscal year 2022–23.

Safia introduced Tiana, the new program manager for SAFG/DDC grants. Tiana presented infographics that provide a brief visualization of many things including the number of courts being served by the SAFG/DDC grant funding, a breakdown of the number of collaborative courts that participated, the number of estimated participants they are serving, as well as gain information on how the SAFG funds are being utilized by the courts.

By using Qualtrics, Safia and Tiana streamlined the process of data collection from the courts. Data is now in one location and after the completion of the application, the court can see its estimated eligible funding.

Webinars were also created for courts as a detailed resource when they're applying for the SAFG and DDC grant. They are located on the Judicial Council website along with the infographics (at https://www.courts.ca.gov/3080.htm).
