The Language Access Signage and Technology Grants, Cycle 7 recommendations and proposed allocations were approved by the Judicial Council at their July 18, 2025 meeting. Also, training resources developed for court staff on the appropriate use of the California Courts Voice-to-Text Translator application have been completed and made available to pilot courts.

Equal Access Fund: 2025-26 Distribution of Funds to the Access to Justice Commission

The committee reviewed distribution of up to \$5 million to the California Access to Justice Commission for grants to civil legal aid nonprofits and \$250,000 for administration of a tax-advantaged student Loan Repayment Assistance Program.

Action: Mr. Lawrence Meyer moved to approve the draft report and distribution of funds to the Access to Justice Commission and administration of tax-advantaged student Loan Repayment Assistance program. Justice Thomas Delaney seconded that motion. With no opposition or abstentions, the motion carried.

The committee considered a rules and forms proposal to implement Assembly Bill 1899 (Stats. 2024, Ch. 812). This legislation requires the Judicial Council to adopt a standard of judicial administration to ensure the inclusivity of juror identification and juror questionnaires. The proposal will include a new standard, as well as revisions to existing Judicial Council materials to replace gender-based terminology related to jurors.
