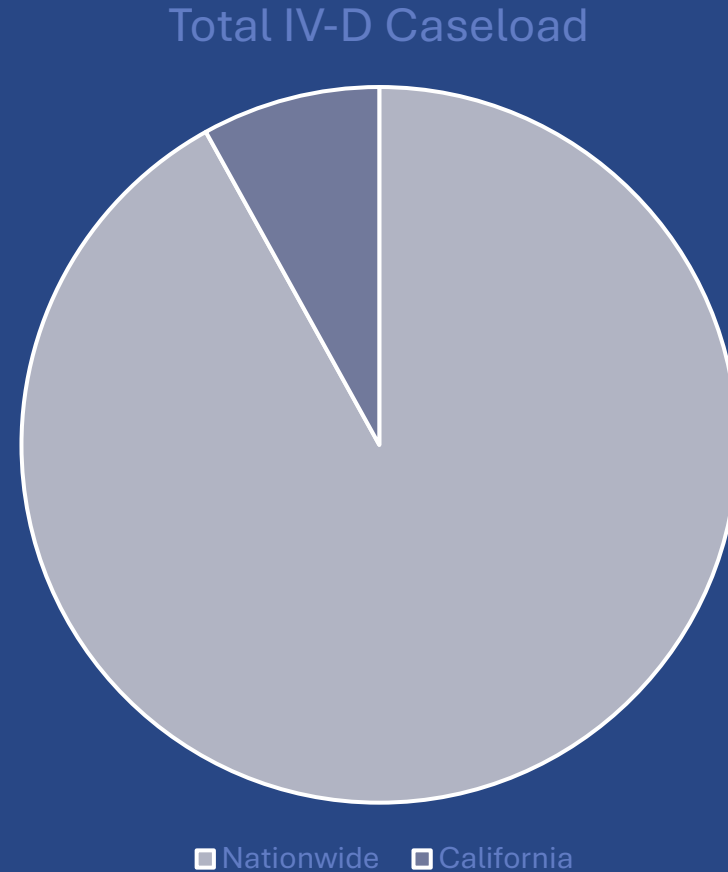


# Child Support Milestones in 2025-2026

# Big Picture Outcomes

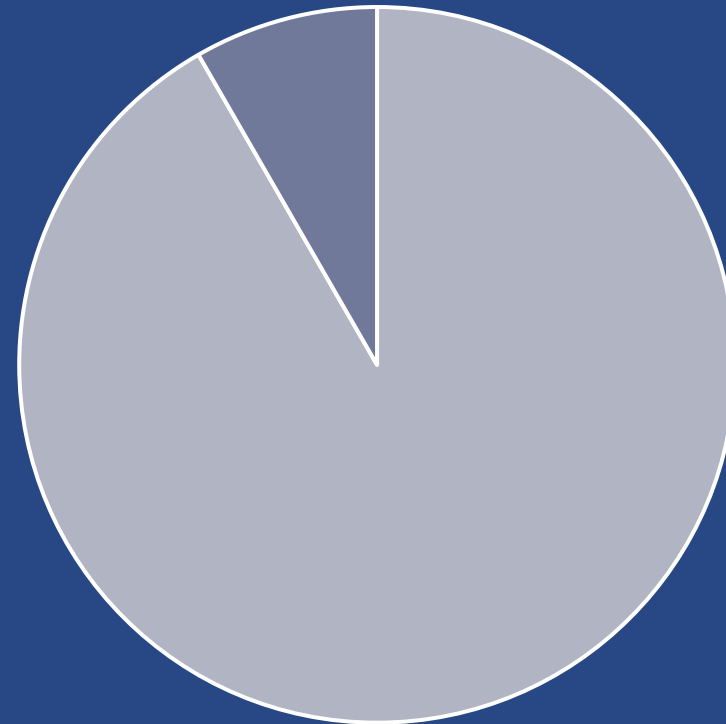
California serves 9% of the national child support caseload

Distributed Collections

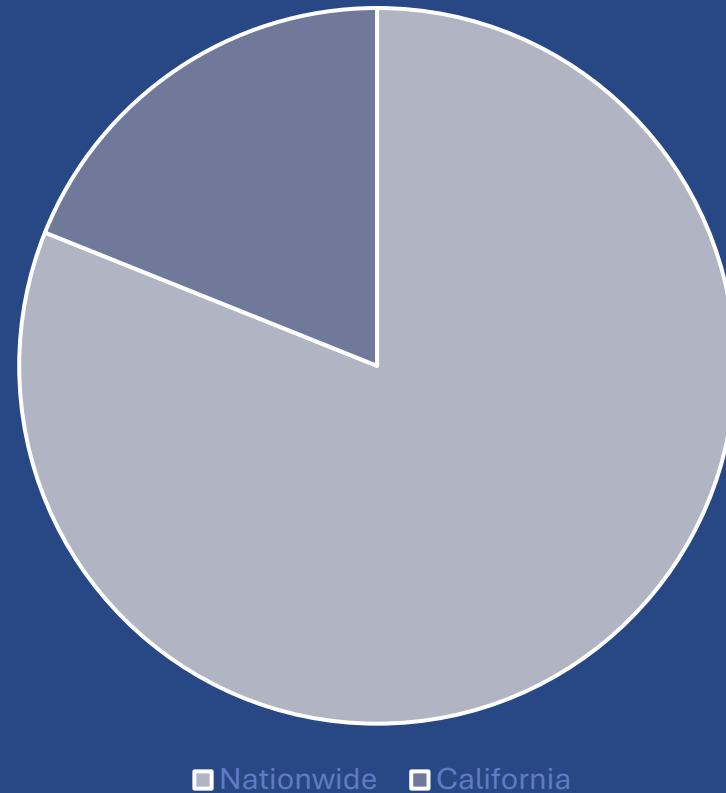

California manages over 20% of all currently assisted cases nationwide

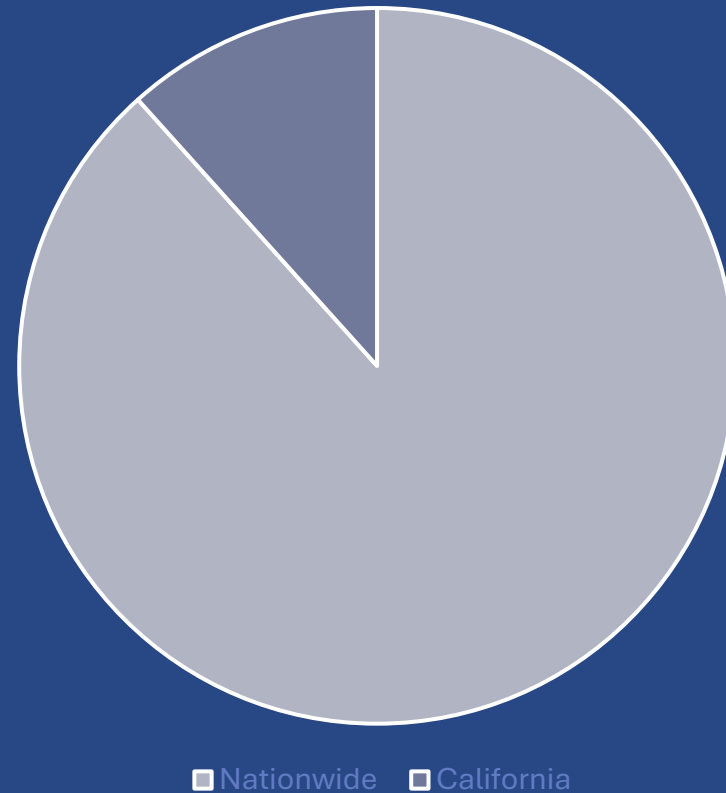
Currently Assisted Caseload
