Rules of Court, rules 3.50, 3.51, 3.52, 3.53, 3.55, 7.5, and 8.26; revise forms APP-015/ FW-015-INFO, APP-016/FW-016, APP-016-GC/FW-016-GC, FW-001, FW-001-GC, FW-001-INFO, FW-002, FW-002-GC, FW-003, FW-003-GC, FW-005, FW-005-GC, FW-006-GC, FW-007-GC, FW-008, FW-008-GC, FW-010, FW-010-GC, FW-011, FW-011-GC, FW-012, and FW-012-GC (Action Required)**

Review public comments on the proposed changes to the rules and forms identified above, approve responses, and recommend placement on the consent agenda for the Judicial Council’s October 24 meeting. The proposal amends rules governing fee waivers in civil and probate judicial proceedings as well as revises the forms used to request and determine requests for those fee waivers by persons who file petitions for appointment of guardians or conservators and appointed guardians or conservators representing the interests of wards or conservatees. The recommended revisions implement recent legislation, correct identified misapplications of the governing legal framework, and simplify the language to make the forms easier to understand.

Review public comments on the proposed rule amendment and form revisions identified above, approve draft responses, and recommend placement on the consent agenda for the Judicial Council's October 24 meeting. The proposal recommends a new form for use to petition for the joint guardianship authorized by AB 495, revisions to other forms to accommodate the statutory change, and technical revisions to correct nonsubstantive errors and update the forms to reflect current formatting standards.
