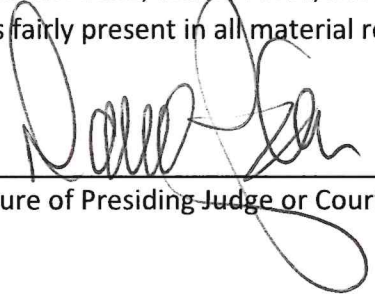
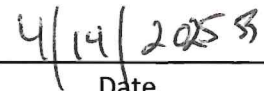


QUARTERLY FINANCIAL STATEMENT CERTIFICATION
