The Judicial Council is pleased to support SB 717, which authorizes the issuance of a search warrant to allow law enforcement officers to take a sample of blood or other bodily fluid that may be used as evidence in misdemeanor driving under the influence cases when a person refuses to submit to or complete a blood test as requested by the officer.

The Judicial Council supports SB 717 as a necessary response to the United States Supreme Court's ruling in *Missouri v. McNeeley* that a search warrant is generally required to conduct a blood test of an individual suspected of driving under the influence. SB 717 makes it clear that courts may issue search warrants under these circumstances.
