Review recommendations for redistributions of funding for court appointed juvenile dependency counsel for 2018-19.

Action: The Trial Court Budget Advisory Committee unanimously approved the following three recommendations:

- 1. Allocate \$783,316, the 2017-18 Juvenile Dependency Counsel Collections Program (JDCCP) funds remitted in excess of dependency counsel program administrative costs, to the trial courts calculated according to the methodology adopted by the Judicial Council at its August 23, 2013 business meeting.
- 2. Allocate \$659,744, the 2018-19 Court Appointed Counsel expected unspent funding, to the trial courts calculated according to the methodology adopted by the Judicial Council at its January 22, 2015 business meeting.

3. Direct Judicial Council staff to further survey courts regarding their ability to utilize funds during the remainder of the fiscal year, reallocate unspent funds to those courts demonstrating an ability to expend funds by the end of fiscal year, and report on the final allocation to the Judicial Council at its July 18–19, 2019 business meeting.

Subject: 1% Price Adjustment

Sacramento Superior Court is experiencing increased costs for employee compensation and other costs that are currently unfunded. In order to meet cost increases Sacramento is requesting that Judicial Council seek a 1% branch wide price adjustment by requesting a 2019-2020 Spring Finance Letter totaling \$18.98 million. Sacramento would receive approximately \$781,000.

As you know, state departments are funded for employee compensation increases. Because the Judicial Branch is not funded for employee compensation increases, it creates unique problems for the Courts. It is difficult to negotiate multi-year contracts when it is uncertain whether Court's will receive additional funds to pay general salary increases and reserve limits of only one percent of a court operations budget.

Sacramento Court staff compared average salaries for the Court compared to the Executive Branch from 2012-13 to 2018-19. Over that time period, while executive branch average salaries have increased by about 35 percent, Sacramento Superior Court's average salaries have only increased by about 10 percent. See attached chart "Court vs. State Executive Branch Average Salary Only."

As part of the recently concluded collective bargaining agreement in Sacramento, the Court negotiated contingency language for an ongoing 1 percent general salary increase if the Court receives \$650,000 in ongoing funding for employee compensation or discretionary funds. The January Budget does not include any discretionary funding that would allow the trigger to implement the on-going general salary increase.

In addition to increased salary costs, the Court is experiencing cost increases for maintenance agreements for CMS systems. The Court is also experiencing cost increases for licensing agreements and hardware costs.

A 1% base increase of \$781,000 would allow Sacramento to fund a 1% increase for employees and also fund some of the increased costs for information technology maintenance, licensing and hardware.

As you may know, after a new Governor takes office, the Legislature affords the Governor some latitude to submit new proposals during the Spring Budget process. We are hopeful that the Judicial Council will submit a proposal to begin conversations with the new administration regarding some structural budget issues unresolved since realignment of the trial courts from the county to the state in the late 1990's.
