#### Issue

Consideration of a recommendation to allocate State Trial Court Improvement and Modernization Fund (IMF) funding for reinstatement of EAP services for funded trial court judgeships statewide effective December 1, 2022, for consideration by the Trial Court Budget Advisory Committee (TCBAC), the Judicial Branch Budget Committee (Budget Committee), and then the Judicial Council at its November 18, 2022 business meeting.

#### **Background**

The Judicial Council's Human Resources (HR) office currently contracts with Humana as the EAP provider for the state level judicial branch entities. Through the provider's network of health professionals across the state, the judicial branch's EAP provides active members up to six visits per issue for use of assessment, crisis intervention, short-term counseling, and referrals to community services. Trial court judges previously had access to the judicial branch's EAP services funded through the IMF. In August 2013, the Revenue and Expenditure (R&E) Subcommittee recommended elimination of funding and services due to low utilization,<sup>1</sup> which was approved by the TCBAC<sup>2</sup> and then the council in April 24, 2014.<sup>3</sup>

In May 2022, the HR office conducted an informal poll of approximately 20 percent of trial courts to assist in determining the level of EAP services that courts are providing directly to judges, and identified that approximately 64 percent of courts polled do not currently provide these services.

## Cost Impact

The HR office is currently conducting a request for proposal (RFP) for a contracted EAP provider as services through Humana will cease effective December 5, 2022. Using an estimated cost of \$2.00 per judge per month, with an anticipated increase of approximately 3.5 percent annually, the estimated cost for 1,757 funded judgeships is shown in the table below (actual costs may come in higher or lower based on the outcome of the RFP).

The current 2022-23 council-approved IMF allocations by office are included as Attachment A, with the most recent IMF fund condition statement included as Attachment B.<sup>4</sup> The IMF will end 2022-23 with a fund balance of \$16.5 million, of which approximately \$13.8 million is unrestricted.

### **Recommendation**

To ensure trial court judges have access to EAP services and based on the current fund condition of the IMF, it is recommended that the R&E Subcommittee approve an increase to the 2022-23 IMF allocation to the HR office in the amount of \$27,500 effective December 1, 2022. This amount reflects a 10 percent increase in the cost estimate should the final contract costs come in higher than estimated, for consideration by the TCBAC, the Budget Committee, and then the council at its November 18, 2022 business meeting.
