



Reason for Increase: The cost increase is due to the construction bid which is much higher than the County estimated. The construction escalation since the project approval has been 13%.

Reason for Increase: The scope of work increased due to an added requirement by the State Fire Marshal (SFM) to fully repair all non-rated penetrations made to the fire-rated walls. The penetrations have compromised the fire rating of the walls. The penetrations were made prior to the transfer of the building and were unforeseen.

Notes: FM Program Budget Share is 100%, therefore cost increase to FM Budget is \$790,000.




Statewide Map





Enovity BANCRO - Preventive Maintenance







Riverside Court Past Due SWOs






