Where do we get our water?

From the Ground



From Surface Sources (Lakes, etc.)



Where we get our water impacts how we need to treat it.

Ground Water Properties:

- Higher Concentration of Dissolved Solids (generally due to minerals)
- Lower Concentration of Suspended Solids
- Low Organics
- Generally higher in Iron and Manganese (Fe and Mn)
- High concentrations of Silica
- Generally consistent quality (you know generally what you are going to get)



Surface Water Properties:

Corrosion: Characterized by pitting or creving not be evident until the pipe states


