







Reason for Increase: Fire watch was required by the State Fire Marshal due to modifications for the system. In addition, there were delays in obtaining parts due to COVID 19.

Notes: FM Program Budget Share is 74.56%, therefore cost increase to FM Budget is \$48,464.




Orange Court Preventive Maintenance








Riverside Court Past Due SWOs






