MASTER AGREEMENT USER INSTRUCTIONS

These User Instructions are provided for the Closed Captioning Services Master Agreement with Verbit, Inc. (the “Contractor”). The Judicial Council issued a Request for Proposal seeking vendors that could provide closed captioning services to the judicial branch. Any Judicial Branch Entity (JBE) that wants to use the master agreement **must enter into a Participating Addendum** with the Contractor. Please carefully review these User Instructions.

1. Process

Any JBE that orders services under this Master Agreement must enter into a Participating Addendum and place work orders for the Services using Verbit’s online ordering system (<https://order.vitac.com>) for real-time captions or the customized Work Order Request Form (Appendix F) for offline captioning services. Appendix F, provided by the Establishing JBE, can be

customized for Participating JBEs based on their user group IDs, accounting codes, and service needs. Appendix A of the Master Agreement, section 2.6 discusses the ordering process.

2. Participating Addendum

Each Participating Addendum is a separate, independent contract between the Contractor and the entity entering into the Participating Addendum, subject to the following:

- (i) Each Participating Addendum is governed by the Master Agreement, and the terms of the Master Agreement are incorporated into each Participating Addendum;
- (ii) a Participating Addendum may not alter or conflict with the terms of the Master Agreement, or exceed the scope of the services provided for in the Master Agreement; and
- (iii) the term of a Participating Addendum may not extend beyond the expiration date of the Agreement.

3. Create Work Order Request

After the Participating Addendum (Appendix E of the Master Agreement) has been signed by the JBE and the Contractor, the JBE should use Verbit's online ordering system to place Work Orders for real-time captions or use the JBEs' customized Work Order Request form for offline captioning services. The JBE should also send the request via email to Verbit's contact person, **Barbara Moretti**. The JBE can create a purchase order to encumber the funds. The Header Text of the purchase order should include language such as "This purchase order is for the purpose of ordering closed captioning services against the Judicial Council Master Agreement No. **MA-SF2026-01** and the Participating Addendum signed by the JBE on _____." The purchase order must indicate the dates and times that the closed captioning services are required and any other pertinent details.

4. Miscellaneous Information

- (ii) JBEs will be notified when the options to extend are elected and/or when the Master Agreement is modified or amended. All amendments will be posted on the procurement website with the Master Agreement.
