## Private Attorneys General Act (PAGA) Case Search

Please enter one or more search criteria to find filings submitted to the LWDA pursuant to the Private Attorneys General Act (PAGA).

*Note: The searchable database includes most PAGA claims filed with the LWDA since 2004. Prior to June 27, 2016, only employee claims, employer cure notices, and employee cure disputes were required to be filed. Since that time, parties have also been required to file copies of court complaints, settlements, and certain orders, first by email (through 9/5/2016) and then through the current online filing system.*

*UPDATE: As of December 21, 2020, certain documents, including court related documents (i.e. court complaints, proposed settlements, and court orders/judgments) are available for download.*

“Submission Type” and “Date Range of Submission” are required when conducting searches by specific searchable data such as Business, Lawfirm, Individual Name, LWDA Number, Employer City, Employer Zip Code, Court Case Number and/or Court Type and Court Name.

To search for LWDA Case numbers, you must input the name of the entity and on the “Date Range of Submission” your search must begin on 09/06/2016. For example, 09/06/2016 – 10/01/2018 or 09/06/2016 – current date.
