While the Court Transfer Process is completed, there are still a number of facilities where the transition of services from the county to the Judicial Council has yet to occur, additionally the agreements between the Judicial Council and the counties regarding management and responsibilities for court facilities are subject to changes over the course of the terms of the Contracts. In addition, some facilities are leased and, in some instances, the maintenance of the facility will be provided by the landlord. The Judicial Council is also in the early stages of a major Capital Project that will result in the construction of multiple new courthouses during the term of the Contracts. New Facilities may be added to this list and may require maintenance by Contractor. Some facilities will cease to have court operations and thus will no longer require services.
