Paragraph 5.2.5 - Tab 5 seems to require the same certification and declaration forms and refers to every individual of the Design Build Entity. Please confirm Tab 1 is to include certification and declaration from the Design Build Entity and Tab 5 is to include certification and declaration forms from other members of the Design Build Team and also, if applicable, include individual members of the Design Build Entity.	Please refer to RFQ Section 5.2.
2	Attachment 1 Prequalification Questionnaire, Section I, Question 5 & 6	The questions asks for licensing information for the Design Build Entity's design professionals. These questions do not appear to anticipate that design services might be provided by the Design Build Team as the questions 1 through 3 in Section II do. Please confirm Questions 5 and 6 in Section I may include licensing for members of the Design Build Team, not necessarily only the Design Build Entity.	Questions 5 and 6 may include licensing information of the Design Build Entity.
3	Attachment 1 Prequalification Questionnaire, Section I, Question 14	Financial statements are highly confidential and proprietary corporate information. For the RFQ, we are requesting that a surety letter be acceptable as evidence of our financial capacity to complete the project. Please confirm.	Please refer to Section I, Question 14, for specified requirements.
4	Attachment 1 Prequalification Questionnaire, Section III, Subpart A, Question 1	The question references "in area" to the three largest projects. Please confirm "in area" refers to size (sf) of the project in California. And are we allowed to provide more than three projects since there are 5 lines on the table provided for this question?
