This Addendum 1 hereby modifies the RFP as follow:

1. Deletions in the RFP are shown in strikeout font (~~strikeout font~~); insertions are shown in bold underlined font (**bold underlined font**). Paragraph numbers refer to the numbers in the original RFP.
  
2. The following change is made to Section 5.0, Candidate Qualifications, specifically subparagraph 5.2.1 on page 4 of 10 of the RFP:

“5.2.1 Experience with SAP integration with third party providers, **e.g., Kaiser, HealthNet, Delta, EyeMed, Minnesota Life, Hartford, ING, SBCera, and EAP**, particularly in the area of payroll/benefits.”

3. The following change is made to Section 2, Work Requirements, paragraph A on page D-1 of Attachment 2, Contract Terms:

“2. Work Requirements

- A. **Most Work will be performed on site at the AOC’s office in San Francisco, CA, with some travel to Sacramento or Southern California approximately once per month.** The Contractor’s Key Personnel shall perform the Tasks set forth below in Table 1a starting *[Estimated Dates]* **April 2010 through March 2011, or March 2012 [if the AOC exercises the First Option Term], or March 2013 [if the AOC exercises the Second Option Term]**, and deliver the Deliverables set forth in Tables 2a, 2b, and 2c, below:”
