3. Responses to Questions

A. Court visits and tours:

- Old Solano Courthouse: A tour of the courthouse will be arranged prior to the interview date for short-listed firms. Those firms will be notified in writing directly of the date and time of the tour after confirmation with the Court. The building is currently closed.
- New courthouse projects: The short-listed firms should not visit or contact the courts at this time. If you need additional information, refer to the Project Feasibility studies posted on the website as part of the RFQ.

B. Interview questions and times:

- Interview locations are posted with the interview schedule.
- Times are set at the Courts' convenience and are not subject to revision.
- All locations are standard conference rooms with A/V and presentation capability.
- Teams must bring their own presentation materials and equipment (e.g. projectors and laptops).
- Teams cannot visit ahead of time.

C. Interview format:

- One hour interview formats will include: 45 minutes team presentation; 15 minutes Q&A.
- Plan for approximately 10 minutes for set up and breakdown, excluded from the one-hour allotted.
- Any format for presentation may be utilized which demonstrates best the team's qualifications for the subject project.

D. Scoring/ranking following interviews:

- Scoring/ranking is per the published RFQ, i.e. teams will be rescored by published criteria following the interview.

E. Time to prepare:

- We have endeavored to allow at least 4 weeks for each team to prepare, from publication of short lists to interview.

F. A&E team members:

- Prime architect should bring key team members as appropriate; this is not limited to a particular member or number of members. Key consultants may be included as appropriate, e.g. historic preservation, programming, structural engineer or other consultant(s).

G. Final disclosure of decisions/awards:

- Awards will be announced after interviews have been completed for all 13 projects. This is expected to be on or after October 15, 2009. No disclosures or announcements of awards will be made prior to the date. Please do not contact the AOC or Courts regarding awards/decisions after your interview.

H. Distribution of documents:

- In regard to requests for copies of the firms' proposals during or after this solicitation, the AOC is not bound by the Public Records Act, however, it is our policy to generally comply with its requirements. It is the policy of the AOC not to release copies of proposals nor conduct debriefings until after the contracts resulting from an RFQ have been signed.
