## Attachment 1: Information Sheet

- Information about the court and funding by county
- Location and number of dependency courtrooms
- Current range of child and parent clients
- Service providers are expected to provide representation for every case filed or a proportion thereof, including all levels of conflict.
- Total funding available FY 2017-2018 through FY 2019-2020
  - Contracts to represent child clients are limited to 55% of total funding or a proportion thereof
  - Contracts to represent parent clients are limited to 45% of total funding or a proportion thereof

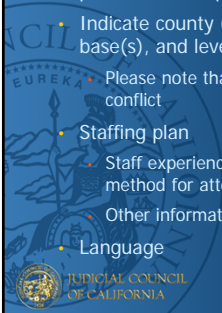

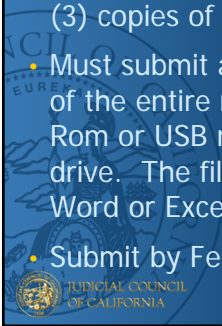

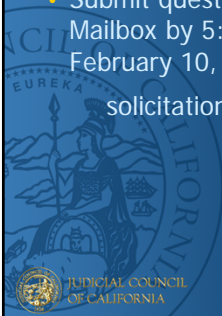
