#	RFP Reference (Page-Section)	Question	Response
1	Page 4, Section 1.3	Does the JCC intend to complete additional audits in the time period of this contract period?	It is possible, but at this point in time we are focusing on implementation of the energy efficiency measures identified in the existing audits.
2	RFP, page 5	For the development of the sustainability policy moving forward, are we to submit a formal policy that would be documented at the state level or would we providing language that JCC would develop for formal policy?	Consultants will not develop a sustainability policy per se, but might identify policies that support an overall sustainability program. For example, consultant might identify the need for a policy related to back up power that supports the use of battery storage systems.
3	Page 5, Section 2.1, and Page 4, Section 1.3	Can the JCC clarify what level of utility data analysis has been completed through efforts with utilities to identify inefficient buildings (referenced in section 1.3) versus what is envisioned in Section 2.1 in the "organization and analysis of utility data"? Is the JCC intending for the consultant to perform portfolio benchmarking?	The utilities performed a quick energy usage intensity (EUI) analysis for us, based on our account information. The JCC is in the process of soliciting an on-line, web based energy dashboard, which will assist with additional analysis. In the interim, we might need to look at the entire portfolio in order to prioritize sites for energy efficiency projects.

Generally, rate analysis using commonly available data is acceptable. For projects where new usage patterns are proposed, rate analysis may require factors beyond the tools utilities offered, such as using forecasted data based upon project implementation or future occupancy change, etc.
5	Page 5, Section 2.1	Regarding "Identification and assisting with implementation of energy efficiency measures" does the JCC intend for the consultant to perform full project management and construction management services related to energy and sustainability project implementation?	No, more like assisting with prioritization and reviewing proposed scopes of work.
6	Page 5, Section 2.1	Does the JCC intend for RFPs to address ECMs across building portfolios, or to seek project implementation resources who can implement multiple ECMs within a building?	No.
7	Page 5, Section 2.1	For "Identification and evaluation of on-site self-generation options", does the JCC intend that the consultant perform a QA/QC type review of recommendations already made through utility audits, or that the consultant perform additional evaluations of self-generation opportunities, costs, and benefits?	Additional evaluations of self-generation opportunities.

Please complete Attachment 5 and include it with the Proposal Package. It can be attached at the end of the proposal.

If it's the electronic copy, do we need to have a separate USB drive for Part One and Part Two in addition to the whole package USB drive?	The JCC requires one printed copy and one electronic copy of the entire Proposal. You may include both Part One and Part Two on a single USB drive. Please name the files for easy identification and for readability purposes. Limited to 15 characters per naming convention.
19	Page 10 – Section 7.3	In the electronic format, do you want the cover letter, proposal content and all the attachments in a single PDF or as individual files on the USB drive?	A single PDF is preferred for both the Qualifications, attachments, etc. and the Cost Proposal. The PDFs should be separate PDFs, included on two USB drives. One drive should have the Qualifications, attachments, etc. The other drive should only have the Cost Proposal. The PDF is requested to facilitate easy printing.
20	Page 11, Section 8C	The RFP request that we provide a description of similar services conducted for five (5) separate clients. If we have a client that we provided similar services for on a number of projects, can we only list one of the projects? For example: Will we be disqualified if we list four (4) separate clients, but show five (5) separate projects?	Please provide a description of similar services conducted for five (5) separate clients. There is no limit on the number of projects you include, but we would like to stress quality over quantity.

Please note the clarification on the RFP website. A contractor's license is not required.
23	13.10 – Page 16	Is a general contractor required to perform work at any facility? The ten bullet points mentioned under 2.0 - Scope of Work (Page 5) do not indicate any obvious requirements for construction.	This contract is for services only. No construction will be included in these contracts.
