**ANSWER:**

**Currently, there are 61 sites.**

22 QUESTION: Are all of the sites currently in Drupal?

**ANSWER:**

**We currently have about 35+ sites on Drupal. The Judicial Council Web ecosystem comprises of 61 websites in total.**

**There is currently one WordPress site.**

24 QUESTION: If there are not WordPress sites currently, why is that mentioned?

**There is a possibility that we may need to migrate Wordpress sites onto Drupal and vice versa.**
