7	Section 3.5.1 (Fee Proposal – Hourly Rates) indicates that the hourly rates in the fee proposal shall include the cost for travel and per diem expenses. Since we don't know the location or duration of each individual project it is not possible to build these costs into an hourly rate schedule.	RFP: Request for Proposal Page 7 of 12 Section 3.5.1 (Fee Proposal – Hourly Rates)	Cost for travel and diem expenses does not need to be included in the Proposal. See section 3.5 of Revision 1 for revised language.
8	Section 3.2.1.1 of Exhibit D indicates "The price for all services, the cost of any expected Travel and Living Expenses, and the cost of any expected Reimbursable will be added to calculate a lump sum price" This indicates that the Travel and Per Diem are negotiated on an individual Service Work Order and not part of the hourly rate. Please clarify.	Agreement: Section 3.2.1.1 of Exhibit D	Cost for travel and diem expenses does not need to be included in the Proposal. See Section 3.5 of Revision 1 to the RFP for revised language. Travel and Per Diem will be based on the Standard General Services Administration ("GSA") rates.
