#	RFP Reference	Question	Answers
1	RFP	Is the RFP specifically intended to be awarded to a DVBE?	No. The State of California requires a 3% participation goal for DVBEs. Refer to Section 9 of the RFP.
2	RFP	Will a proposal be disadvantaged if there is no DVBE participation?	The DVBE documentation is not required at the proposal stage. Refer to Section 8 of the RFP.
3	RFP	Will modifications to the State of California Standard Agreement be allowed?	Submission of your proposal is acknowledgement that proposer takes no exceptions to the Standard Agreement.
4	RFP	Is there an estimate of the potential value of the RFP?	It is anticipated that contracts will be issued to three (3) vertical transportation consultant service providers on an IDIQ basis. There is no value estimate for each, any or all of the contracts. Current properties are throughout the state and tasking at any of the properties is possible. In addition new facilities currently in design which may provide additional potential value.
5	RFP	Is there a comprehensive list of the possible properties to be included in the RFP?	A comprehensive list will not be provided as consultant may be tasked work in any of the existing or under design properties throughout the state.

6	Item 4.6 on page 7 of the RFP	This item notes that proposals should include 'Profile of Firm's Experience' Can you please provide further detail as to the specific material each potential consultant is required to submit? We are a multidisciplinary firm, however this RFP is specifically for vertical transportation consulting services. Is it the intention of the AOC to receive a brief overview of each potential consultant's experience over the past 5 years including all disciplines? Or specific to this specific service? We ask because a profile of our entire firm's experience over the past 5 years would be extensive.	In 4.6 provide a profile of the firms experience and annual average revenue to include vertical transportation consulting services and other disciplines provided by the firm. Responses to 4.3, 4.4 and 4.5 should be most specific to the vertical transportation services requested in this RFP.
