- 5.1 Included as part of this RFP are the following attachments:
 - 5.1.1 <u>Attachment A, Administrative Rules Governing Request for Proposals.</u>
 Proposers shall follow the rules set forth in Attachment A, in preparation of their proposals.
 - 5.1.2 <u>Attachment B, Contract Terms</u>. The contract with the awarded vendor will be signed by the parties on a State of California Standard Agreement form and will include terms appropriate for this project. Terms and conditions typical for the requested services are attached as Attachment B to this RFP.
 - 5.1.3 Attachment C, Vendor's Acceptance of the RFP's Contract Terms or Exceptions to Contract Terms. Proposers must either indicate acceptance of Contract Terms as set forth in Attachment B, or clearly identify exceptions to these Contract Terms. If exceptions are proposed, then proposer must also submit (i) a red-lined version of Attachment B that clearly tracks all proposed changes (additions, deletions, modified language, or new provisions) to this attachment, and (ii) written documentation to provide an explanation or rationale for each individual change proposed.
 - 5.1.4 Attachment D, Payee Data Record Form. The AOC is required to obtain and keep on file, a completed Payee Data Record for each vendor prior to entering into a contract with that vendor. Therefore, vendor's proposal must include a completed and signed Payee Data Record Form. A copy of the Payee Data Record Form is included as Attachment D.
 - 5.1.5 <u>Attachment E, DVBE Participation Form.</u> Proposers must demonstrate either (i) DVBE compliance with minimum participation goals, or (ii) written evidence of a "good faith effort" explaining why compliance with DVBE goals cannot be achieved. The DVBE Participation Form is included as Attachment E.
 - 5.1.6 <u>Attachment F, Cost Proposal Form</u>. Proposers shall use Attachment F, Cost Proposal Form, to propose rates and fees for the services set forth in this RFP.
 - 5.1.7 <u>Attachment G, Reference Form</u>. Proposers shall use Attachment G, Reference Form to provide a list of at least five references, covering at least the last three years, private industry, as well as public entities, to document the quality of the project examples submitted.
